#### I. Call to order

## III. Open issues

- a) Introduction of Officers- No issues present at this time
- b) Treasurer's Report The account balance, expenditures and transactions were presented to homeowners. It was stated that William Fohey, developer will be invoiced 11/40<sup>th</sup> of the bill for the road repair done.
- c) Budget The previous budget and current budget were presented.
- d) Dues schedule- The dues schedule was presented to homeowners including current and past due for 2010. Bills were given to homeowners present at the meeting and the rest are to be mailed to each homeowner. 2010/2011 Dues are to be paid by 8/31/2011. - f) 2011 Snow Removal Program It was stated that snow removal, at this point will continue to be the responsibility of our community. This service will not be provided by the township. 2010/2011 season surplus was refunded at and earlier date.
